GOAL AREA ONE - SUSTAINABLE INFRASTRUCTURE

OBJECTIVES

- 1. Identify and establish sustainable financial model(s) for major capital projects, Old Village business district, 35th District Court, recreation department, and public safety
- 2. 1. CALL TO ORDER

Chair Hess called the meeting to order at 5:33 p.m.

Present: Chair Don Hess and Trustees Pat Grzywacz, Jill Marecki, and Kathleen Hier

Excused: Trustee Kathy Townsend

Also present: City Comm. Liaison Linda Filipczak Department of Municipal Services staff

2. CITIZENS COMMENTS

Bob Bake of 1303 Park Place expressed his dissatisfaction with various elements of the cemetery. Jim Burrows of 1014 Dewey explained the Keep Plymouth Leafy project of physically tagging all of the trees within the cemetery.

3. APPROVAL OF THE AGENDA

Hess offered a motion, seconded by Marecki, to approve the agenda for October 24, 2024.

There was a voice vote.

4. APPROVAL OF THE MEETING MINUTES

Marecki offered a motion, seconded by Grzywacz, to approve the minutes of the May 20, 2024 meeting.

5. TRUSTEE COMMENTS

Grzywacz asked if the spoils area could be fenced or blocked with shrubs. Gerlach responded that he could see if there was money in the budget to screen the area.

Marecki asked if material and equipment staging could be placed in a different location.

6. OLD BUSINESS

There was no old business.

7. NEW BUSINESS

a) Review design development plan for columbarium and mausoleum improvements

Gerlach presented the plan set. He explained the issues with the fastening system, roof, and waterproofing.

The Board discussed the project in detail.

- The fastening system is included in the project.
- The project comes with a minimum 1 year warranty.
- The outbuildings require a new roof, and the original mausoleum roof is in better repair and is not part of the scope of this project.

- Maximizing the wall space was discussed including if the desire was the replicate the existing or go in a different direction which may include additional height and/or depth.
- The rules and regulations for entombment were discussed and the demand from the community. It was explained that there is demand for variety and we need to clarify where we fit into the market. It was further stated that the mausoleum is not in-line with other geographically close cemeteries that were researched for comparison.
- There was consensus that more niches that are in different styles and sizes were desired.
- There was a desire for uniformity with singles in the middle and doubles on the outside.
- There was preference for marble inside the original mausoleum, not glass fronts, to keep it traditional.
- Marecki left at 6:58 p.m.
- There was agreement that a pronounced lower lip would assist with waterproofing and snow removal.
- There was preference for niches to be a single plate with fasteners at each corner.
- There was preference for uniformity with the new niches.

Re: Mausoleum Plan Update

BACKGROUND:

The Cemetery Board of Trustees has been discussing the future of the Mausoleum, specifically niches, for the past few years. In the 2024 City Commission Strategic Plan, the City Commission identified "Plan/budget for mausoleum repair project at Riverside Cemetery" as a one-year task under Goal Area #1 Sustainable Infrastructure. The City Commission considered the proposal from Ehresman Architects at their May 20 meeting. They awarded the contract to Ehresman to move the design concept previously completed to the next phase, which will include construction documents, bidding, and construction administration.

We have scheduled this meeting to continue discussions and review and refine design elements. The Cemetery Board of Trustees' feedback will be incorporated into the plan set prior to moving forward with construction documents. This is the second proposed meeting.

The Cemetery Board of Trustees needs to come to consensus on the following items:

- 1. What type of niches are going to be offered (single or companion or both)?
- 2. Does the board prefer a single style/size of niches or multiple styles/sizes (economy, midgrade, luxury)?
- 3. Will the new niches use engraving on the granite or nameplates?
- 4. Are we completing the interior improvements or not?
- 5. How are we going to structure the pricing (all inclusive or a la carte)?
